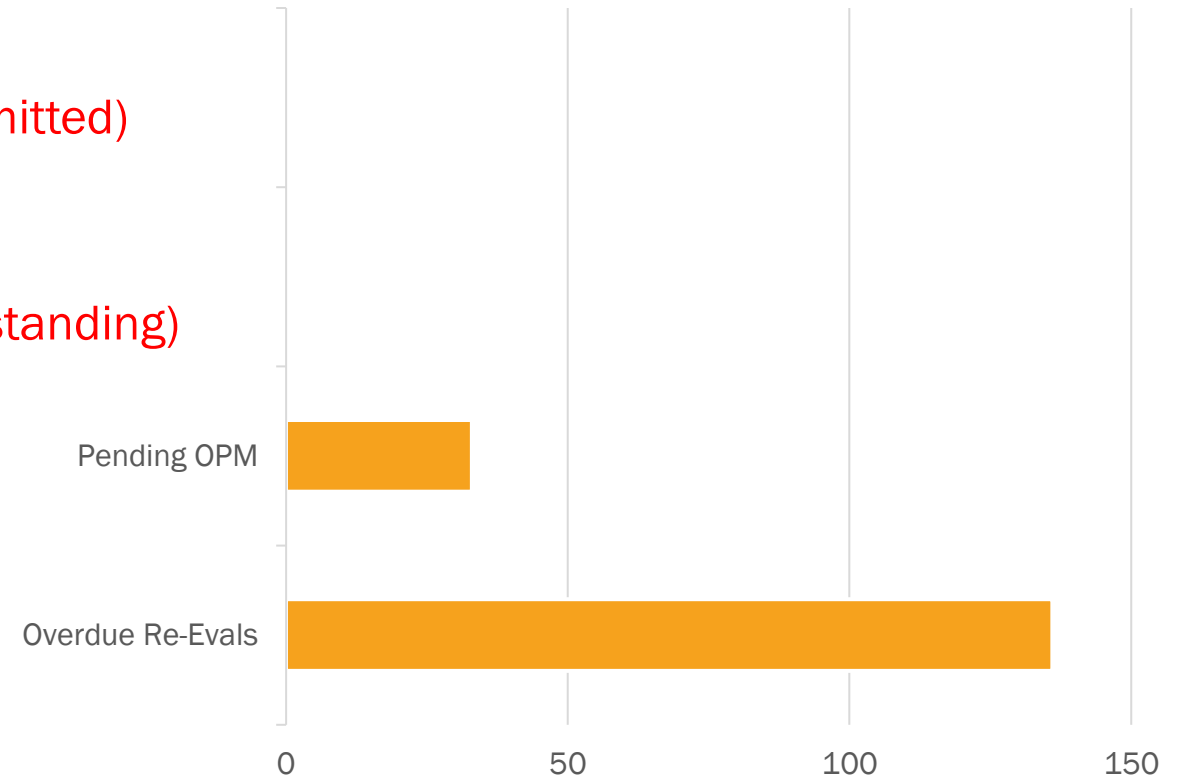

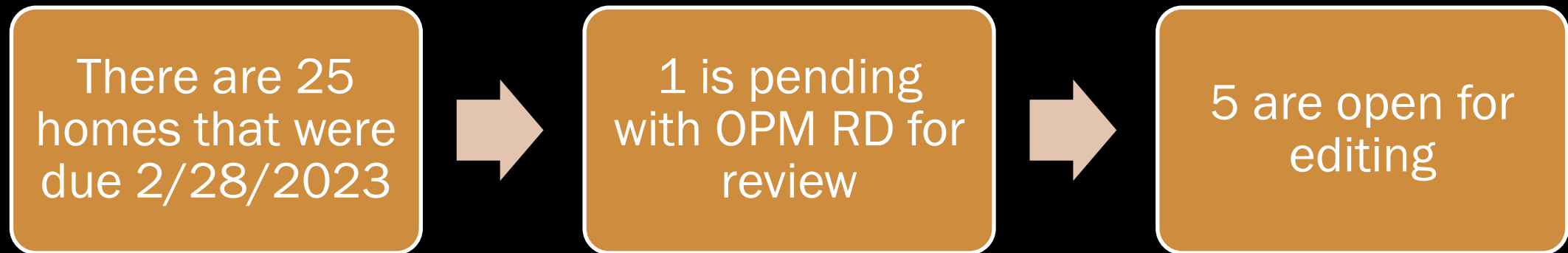
# Re-Evaluations over 90 days

# Policy Reminders



The annual re-evaluation must be completed prior to the expiration of the current foster home approval period. i. No home shall have more than 12 months of approval (e.g., the re-evaluation for a foster home approved 01/10/2019 is due by 12/31/2019).



ii. If a re-evaluation is completed within 30 calendar days of the due date, then the approval term (starting month to ending month) and re-evaluation date will remain the same as it was previously.



iii. If the re-evaluation is completed more than 30 calendar days early or late, then the approval term and re-evaluation date must change
