

2023 CPA Home Count

3283 Total Open Homes at minimum of 1 day in 2023

576 Homes Approved with no prior agency history in GA SCORE

698 Homes Closed and did not reopen prior to 12/31/2023

GA+SCORE 2023 INITIAL HOMES DATA

- 693 homes approved between January 1st and December 31st
 - 285 homes were approved with no requests for edits
 - 408 homes were approved with edits requested at least once

Policy 14.10 Reminder

Complete the initial family evaluation no later than 30 calendar days after the applicant completes all pre-service activities (including pre-service training, home study interviews, submission of all questionnaires, verifications, forms, and other requested documentation. Terminate the assessment process for applicants who do not submit all required documentation within 30 calendar days of completing all pre-service activities.

- Lack of Assessment

GA+SCORE 2023 RE-EVALUATION DATA

- 1215 home re-evaluations approved between January 1st and December 31st
 - 849 were approved with no requests for edits
 - 366 were approved with edits requested at least once

Top Reasons for Re-Evaluations Edit Requests:

- Issues with Forms
- SAFE Questionnaires
- Training
- Updated Safety Screening
- Lack of assessment (FP Discipline, Sleeping Arrangement, updated Water Safety Assessment)
- SAFE Update Mitigation





2023 CPA Home Utilization On January 1, 2023, there were 1716 homes with open placements or placement utilization of 67.43%

By December 31, 2023, there were 1726 homes with open placements or placement utilization of 68.71%.

Any thoughts on how to increase CPA home placement utilization?

Reminder: Recruitment and Retention Plan Policy 14.6

- Recruit based on child specific needs
- Onboard families who can meet the needs of our youth based on the specified needs list: medically fragile/complex needs, LGBTQ+, teens, and sibling groups
- Utilize targeted recruiting based on regional and state needs data
- Use non-discriminatory practices when recruiting families

- Retain homes by considering the level of foster parent satisfaction (Routine Surveys)
- Conduct exit interviews with families leaving your program
- Ensure the caregivers are aware of the grievance process
- Develop respite partnerships
- Offer ongoing foster parent trainings, support groups and meetings (AFPAG)
- Establish a procedure for placement disruptions. Clarify expectations to facilitate a smoother transition to all parties



CPA Home Compliance

48.58% of homes remained in full compliance everyday of 2023 and 51.42% of homes fell out of compliance on any day in 2023.

On January 1, 2023, there were **84.37**% of homes in full approval status.

As of January 1, 2024, there were 89.97% of homes in full approval status.

Five Year Re-certification \

- Re-evaluation Policy 14.13 Reminder Provide caregivers at least 90 calendar days' notice of the need for any medical evaluations or criminal records checks (Fitness Determination Letter) for themselves or household members.
- Conduct a fingerprint-based criminal history records check (CRC) of the National Crime Information Center (NCIC) database on all caregivers and adult household members at least every five years from the date of the Initial Family Evaluation. The CRC must be conducted within 90 days prior to the reevaluation due date (see policy 19.8 Case Management: Criminal Records Checks).

Note

Due to policy and Shines new enhancement **ALL NCIC/GCIC** completed in 2019 needs to be completed prior submitting the re-evaluation. Shines will not allow the home to be processed and approved without the current screenings.



December 28th Eblast & Announcement Reminder

CAP requirements

- Agency Letterhead
- Foster home name/ID
- Children placed in the home
- Reason and Purpose for the Corrective Action Plan
- A <u>detailed</u> plan for completing the required training hours
 - Agency responsibility and follow up, caregiver responsibility, how hours will be obtained, when hours will be obtained(dates of completion), CAP effective dates, etc.
 - Signatures of each caregiver and agency representative(s)

Caregiver Annual Training CAP Requests

On Jan. 1, 2024, the GA SCORE system automatically assigned a CAP to 39 homes due to caregivers being without adequate hours by Dec. 31, 2023

6 Plans Submitted

8 Revision Requests

Why is your agency's home approval status data important?



Ongoing Federal IV-E Funding and Eligibility requirements for the children placed in the home.

Home approval status compliance is critical to meeting federal, state and litigation mandates (Child and Family Service Review and Kenny A Outcomes).

Possible delays in permanency outcome achievement for youth.

Create delays with capturing accurate child placement data in both GA SCORE and GA SHINES system.

Home retention could be impacted if homes are not reassessed timely.

OPM RD Reminders

Re-Evaluation Policy 14.13 Reminder

- Initiate a comprehensive re-evaluation of the household at least 90 calendar days prior to the expiration date.
- The annual re-evaluation must be completed prior to the expiration of the current foster home approval period.
 - i. No home shall have more than 24 months of approval (e.g., the re-evaluation for a foster home approved 01/10/2023 is due by 12/31/2024).
 - ii. If a re-evaluation is completed within 30 calendar days of the due date, then the approval term (starting month to ending month -e.g., 01/1/2023-12/31/2024) and re-evaluation date will remain the same.
 - iii. If the re-evaluation is completed more than 30 calendar days early or late, then the approval term and re-evaluation date must change.

- Approved Placement Age Range
- Approved Placement Capacity
- Approved Placement Gender
- Approval Terms Begin and End Date
- Agency Case Support Worker Name, Contact and Emergency or After-Hours Contact Information

GA SCORE Updates Needed

- •Timely submission of caregiver five-year medical and criminal screenings and 18-year-old household member medical, criminal and safety screenings in GA SCORE
- Ensure the most current agency staff members and agency contacts are always listed in GA SCORE.
- Ensure the most current CPR and First Aid training information is entered in GA SCORE
- •A total of 15 continued parent development annual training hours for each caregiver are needed in GA SCORE. Please try to routinely request training certificates from caregivers and enter the training information in GA SCORE within the month received.
