




Re-Evaluations over 90 days

Five Year Re-certification – NCIC/GCIC

- Re-evaluation Policy 14.13 Reminder Provide caregivers at least 90 calendar days' notice of the need for any medical evaluations or criminal records checks (Fitness Determination Letter) for themselves or household members.
- Conduct a fingerprint-based criminal history records check (CRC) of the National Crime Information
 Center (NCIC) database on all caregivers and adult household members at least every five years from the
 date of the Initial Family Evaluation. The CRC must be conducted within 90 days prior to the reevaluation due date (see policy 19.8 Case Management: Criminal Records Checks).

Note

• Due policy and Shines new enhancement **ALL NCIC/GCIC** completed in 2018 needs to be completed prior submitting the re-evaluation. Shines will not allow the home to be processed and approve without the current screenings.
