RE: 2020 AFPAG Conference State Office Scholarships and Registration Process

The 47th Annual Adoptive and Foster Parent Conference will be held February 28th-March 1st in Jekyll Island, GA. The 2020 conference theme is “*Celebrating Extraordinary Parents*”. The following documents accompany this memorandum as an attachment:

CPA Caregiver Scholarship Recipient Selection:

The Caregiver Recruitment and Retention Unit will support **50 CPA caregivers** through scholarships for the 2020 conference. We recognize how all caregivers could benefit from this conference, and it has proven to be increasingly difficult to select families. However, we encourage you to utilize a fair and unbiased process when making your selections. Scholarships should first be extended to caregivers who have not been afforded the opportunity to attend the conference in the past two (2) years. We also request that scholarship recipients be supported in identifying and securing respite resources for children in their care.

Foster parents selected for the scholarship should meet the following criteria:

1. Exemplify extraordinary work in partnering with DFCS/CPA (participating on panels, mentoring other foster parents, available for respite, etc.)
2. Foster parents who would benefit most and are willing to share knowledge with other caregiver families.

If selected, the scholarship will reimburse the supervising CPA all travel costs associated with the training such as hotel, mileage and meals for the primary and secondary caregivers. **The conference registration fees are the only costs that will be prepaid by the Division.** The registration fee is \$125 per person. Therefore, each caregiver is considered a scholarship recipient, not each family.

Scholarship Selection Form

The 50 scholarships are available on a first come, first served basis. No more than four (4) will be awarded to a single CPA site unless unused spaces remain after the registration deadline. Last year, we successfully supported a total of 50 CPA caregivers to attend the conference and would like to see the same participation this year. The scholarship inquiry form must be

CPA AFPAG Scholarships Recipient Conference Registration and Lodging Instructions:

Lodging availability becomes limited as the conference date looms closer. Therefore, CPA agencies are encouraged to secure lodging as soon as possible for families selected and pay for the costs up front on their behalf. Scholarship recipients are responsible registering for the conference directly with AFPAG. Scholarship recipients must register for the conference using the *2020 AFPAG Conference Attendee Registration Form*. This form is can be found within the AFPAG conference booklet. It must be completed manually and returned as directed in the conference booklet.

CPA Reimbursement Instructions:

If a caregiver is selected for the scholarship, the site contact person listed in the scholarship inquiry form will be notified in writing by January 31st. That official notification must be affixed to the Monthly Pre-Bill statement following the AFPAG conference for reimbursement to be approved. All applicable receipts must be submitted.

Please Note: *Funding availability cannot be guaranteed for reimbursements submitted beyond May 15, 2020 due to fiscal closeout.*
