Winnie Levinson Scholarship Application

THE ADOPTIVE AND FOSTER PARENT ASSOCIATION OF GEORGIA WILL AWARD TWO (2) \$1,000.00 SCHOLARSHIPS

The Winnie Levinson Scholarship is awarded to deserving students who are Georgia residents and are in foster care. Caregivers must be a member of the Adoptive and Foster Parent Association of Georgia (AFPAG). The Winnie Levinson Scholarship is sent directly to the student to use for any educational purpose the student may meet. It is payable in two payments, one at the start of the fall semester and one at the start of the spring semester. Proof of enrollment is needed before payment can be issued.

The applicant need not attend a traditional school. Enrollment at a Technical School, Business School or a Post-Secondary School would also qualify for the scholarship. We encourage all that qualify to apply. The following is a list of all the information needed to process the application.

- ✓ Personal Data- name, address, contact information including e-mail address and phone number
- ✓ Recommendation from three people who do not live with the applicant and have known applicant for a minimum of one year and one recommendation from the applicant's local DFCS on their letterhead.
- ✓ A short (five hundred word) essay on why the applicant should receive this scholarship.
- ✓ A copy of the applicant's high school transcript.
- ✓ A letter from one of the applicant's caregivers telling why the applicant should receive this scholarship.

Workshops Description Session A Friday February 25,2022 10:45 a.m. to 12:15 p.m.

<u>A-1. Nuts and Bolts</u>: The federal regulations for IDEIA 2004 includes a section called Procedural Safeguards. These safeguards are designed to protect the rights of parent and their child with a disability and at the same time give families and school systems several mechanisms by which to resolve their disputes. Understanding the IDEIA Procedural Safeguard is especially important to the parent of the student with a disability This Presentation will provide a review in lay terms the meaning pf your parental rights son you may effectively collaborate with your child's school to ensure compliance and increase student academic and behavioral success Presenter: Dr. Kimberly Gore-Mobley.

<u>A-2. Navigating Early Childhood Services for Young Children in Foster Care:</u> Serving young children in foster care is no small task, Research in the neurosciences has proved that 80 percent of brain development takes place in the by the time a child is five years old, with the first three years seeing the maximum growth. Children in this age group are particularly vulnerable to adverse effects of foster care placement in these early years, quality care and education give children a head start on skill development, school readiness, and future success. This workshop will provide an. overview of the services, support and resources designed to meet the needs of children in foster care under the age of five. The DFCA Early Childhood Collaboration U along with representative from the department of early care and learning (DECAL), will focus on critical areas such as early childhood education options early intervention services and childcare (CAPS). Presenter: Donjae Calhoun.

<u>A-3. Surviving Diversity, we are All in This Together</u>: This workshop will provide recommendations and technics for guiding the foster family through unexpected and difficult events. Whether with the foster children, their families as the foster parents themselves and their families, serious problems are sure to arise. This workshop will explore methods derived from actual experience in surviving these issues with a positive outcome. Presenters: Jim and Iris Gandy.

A-4. Encouraging Resilience in The Era of The Covid; Strategies to Caregivers of Children in Child Welfare: There is a significant research literature that describes the impact of adverse childhood experience (ACE's) and how they affect the developmental trajectory of children. Additionally, we understand the multiplicative impact when a child experience multiple ACE's. What is not known are the impact of (ACE). Covid 19 that impact the whole of a child's life, socially, emotionally, and academically. Researchers predict that the full impact of the Covid pandemic on the psychological adjustment of children will not be fully understood for years as developmental outcome. Children involved in the child welfare system need guidance and support now as do their caregivers foster parent, therapists, and case managers. In this presentation, proven strategies for encouraging positive adjustment or resilience to adversity are found and discussed that promoted positive psychological adjustment. The presentation focuses on the intersection of the various caregiver system school, foster home and therapy that affect the adjustment of foster home and how those system together can promote positive developmental responses to the pandemic. Presenter: Dr. LeRoy Reese.

<u>A-5. Adding Tools to The Toolbox, Traumas Informed Practices and Training for Foster Parents</u>. Through the support of funding from Resilient Georgia, whose mission is to develop a trauma informed public and private network, working towards creating a more integrated behavioral health system, Vashti has been able to provide professional learning and training opportunities to youth serving organizations as well as foster parents. Our workshop will discuss briefly (ACE's) Adverse Childhood Experience, the importance of trauma informed care and practices, the training avail to foster parents through our professional learning program, and we will also share data from program participants. Presenters: Elijah Miranda and Alex English. A-6. The Difference Between You and I, How Youth in Foster Care Translate Your Communication and Love Language: This workshop is a trauma Informed presentation focusing on the barriers as well as communication alternatives and reciprocation from caregivers to foster youth. The Presenter will go over Love Language translation after Trauma, 2. Treatment Team communication with youth Centered Communication, 3, Not About Me without me Policy and four. Care centered verbiage. Presenter: Whitney Lam Gilliard

<u>A-7. Let's Talk Adoption</u>: Whether you are a prospective adoptive parent, a resource parent, or a partnership parent, you want to attend this workshop if you have children placed in your home who cannot return to their parents. Participants attending this workshop will gain knowledge of the requirements and the process to adopt children from Georgia's child welfare system. The primary focus will be on laws governing adoption policy in Georgia and Georgia's best practice supported by adoption policy. Presenter: Karla Wells.

<u>A-8. Post Adoption Services Through Adoption Assistance/ SMI- WHERE'S MY CHECK</u>: Georgia's Department of Family and Children Services looks to provide quality supportive services to adoptive families from the time a child is first placed in the home until the child becomes an adult. These services range from referrals for preventive therapeutic resources to crisis intervention services. This workshop will provide an overview of adoption assistance benefits and describe efforts to improve awareness and access to post adoption services. SMI (System Methods Inc) staff will discuss how foster parents and adoptive parents can look up information regarding their payment using "WHERE" IS MY CHECK." Presenters: Evangel Wicks, Leah Waters-Jamison, Angel Whitman, Becky Jones, and Jennifer Dukes

<u>A-9. Teenagers in 2022: Creating a Positive Foster Experience to Teens and Families</u>: This presentation will tackle misconceptions and assumptions about teenagers needing care through the foster and congregate care system in Georgia. Often overlooked and forgotten investing in teenagers and supporting them through foster congregate care can be a valuable and impactful experience that can change the lives of young people. While the adolescent period may be perceived as challenging, these young people have great dreams and plans. With the right care and training foster families and congregate care facilities can form meaningful relationships to support teens to achieve greatness. Presenter: Julie Wade

<u>B-1. The Transracial Family- "WHAT IS WRONG WITH BEING COLORBLIND"</u>? This workshop will take the audience through my own journey of understanding how my good intentions and belief in colorblindness were not providing my son with the support and love they needed. This presentation will be a judgement free opportunity for foster parent of a difference color to reflect and examine their own perspective while also receiving practical next steps for education, cultural awareness, and resources to better support their children of color.
