The Adoptive & Foster Parent Association of Georgia will award two \$1,000.00 scholarships

The Winnie Levinson Scholarship is awarded to deserving students who are Georgia residents and are in foster care. **PARENTS MUST BE A MEMBER OF** the Adoptive and Foster Parent Association of Georgia. (AFPAG). The Winnie Levinson Scholarship is sent directly to the student to use for any educational purpose the student may encounter. It is payable in two payments, one at the start of the fall semester, and one at the start of the spring semester. Proof of enrollment is required before payment can be issued.

The applicant need not attend a traditional school. Attending a Technical School, Business School or a Post - Secondary School would also qualify for the scholarship. We encourage all that qualify to apply. The following is a list of all the information we need to process the application.

- ✓ Personal Data- name, address, contact information including e-mail
- ✓ Recommendation from three people who do not reside with you and have known you for a minimum of one year and one recommendation from your local DFCS on their letterhead.
- ✓ A short (500 word) essay on why you should receive this scholarship.
- ✓ A copy of your transcript of your high school grades.
- ✓ A letter from one of your parents stating why you should receive this scholarship.

Workshop Descriptions

Workshop Descriptions Session A Friday February 23, 2018 10:45AM – 12:15PM

A-1. CREATING EFFECTIVE PARTNERSHIPS WITH FATHERS:

This workshop has been designed to assist foster parents with exploring and identifying ways to effectively involve men and fathers in the lives of children in the custody of DFCS. Research shows that outcomes are better for children when positive, responsible men are involved in their lives. The child welfare system has often overlooked men as a resource and may be underutilizing men as valuable allies in our efforts to keep children safe and protected. **Presenter: Darrell Green**

A-2. CREATIVE CONFLICT RESOLUTION:

Whether it's with other foster parents, DFCS, the court, or other involved parties, there are going to be disagreements on what is in the best interest of the children we care for. Learn techniques and resources you can use to lessen the negative impact of those conflicts and to make sure that your position is clearly heard. Presenter: Paul Blough

A-3. FOSTER PARENTS UNDERSTANDING AND PREVENTING COMPASSION FATIGUE: This workshop provides a "Tool Box" for how to take care of yourself related to compassion fatigue, also known as secondary traumatic stress (STS). Foster parents are at a high risk of compassion fatigue as they are consistently exposed to children who have experienced trauma through abuse and neglect combined with the lack of appropriate support. This workshop will provide understanding around compassion fatigue symptoms, self-test, and prevention strategies to maintain a healthier you. Presenter: Ebony Taylor

A-4. POST ADOPTION SERVICES THROUGH ADOPTION ASSISTANCE/SMI Where is My Check?: Meeting a child's needs does not simply end after an adoption finalization court hearing. There comes a time when families require post adoption services to assist with their needs long after an adoption has finalized. Families need support services to help with the demands of parenting special needs children. This workshop will focus on the post adoption services offered through the Adoption Assistance program in Georgia. Topics will include coverage on all available post adoption services. In addition to post adoption services through DFCS, there will also be a presentation from System Methods Inc. (SMI), the financial system vendor and partner to Georgia's DFCS. Presenters: Adrian Owens and Leah Waters

A-5. YOU DON'T HAVE TO BE A PERFECT PARENT TO PARENT PERFECTLY: Suzette and Charles Brown, married 33 years, know there are several definitions of being perfect, but being a perfect parent is not one. D.W. Winnicott, a noted pediatrician and psychoanalyst, suggests children turn out best with "good enough" mothers and fathers who do not strive for perfection but rather provide an "adequate environment". By not making your children's world ideal, you allow time for them to learn that they are not fragile, overcome obstacles, learn from mistakes, solve problems and bounce back from adversity. Mrs. Brown's training will definitely help parents with parenting skills. Presenters: Suzette and Charles Brown

A-6. CASE LAW UPDATES FOR FOSTER AND ADOPTIVE CHILDREN: Come to this workshop to hear and learn about the recent appellate laws in Georgia and nationally that might impact you, your child and your case. This workshop will be structured as a lecture with plenty of room for discussion. Presenter: Judge William Bartles

A-7. HOW TO MEET AND ADVOCATE FOR YOUR FOSTER CHILD'S HEALTH CARE NEEDS: Learn how you can ensure that your foster or adopted child's healthcare needs are met with healthcare providers and care management organizations. Presenter: Tom Rawlings

<u>A-8. LET'S TALK ADOPTION</u>: Whether you are a prospective adoptive parent, a resource parent, or a partnership parent, you want to attend this workshop if you have children placed in your home who you desire to adopt. Participants attending this workshop will gain knowledge regarding the requirements and the process to adopt children from Georgia's child welfare system. The primary focus will be on laws governing adoption policy in Georgia and Georgia's best practice supported by adoption policy.

A-9. CREDIT REPORTING AND YOUTH IN CARE: This presentation will discuss the importance of ensuring our older youth in care are aware of their credit score and are connected to a specialist through the GATY/SE Independent Living Program. Presenters: Erika Dennis and Devin Martin

A-10. POST TRAUMATIC STRESS DISORDER (ANOTHER PERSPECTIVE): Foster children are now being diagnosed with Post Traumatic Stress Disorder (PTSD). "Another Perspective" will discuss trauma in children from removal to placement in a foster parent's home. Discussion will focus on behaviors as well as mental health concerns of foster children who are now experiencing trauma. Workshop Descriptions Session B Friday February 23, 2018 3:30PM – 5:00PM

B-1. PREVENTING ADOPTION DISRUPTIONS: HOW TO PREPARE FOR AND COPE WITH TRAUMA ISSUES AND YOUR ADOPTIVE CHILD: Adoptive children are routinely told that when they are adopted, they have found their forever families. Yet increasingly, adoptive parents are taking their children to DFCS and saying that they cannot continue to parent their adoptive children. This situation re-traumatizes children who have already been traumatized by parental abuse and neglect, by years in foster care, and by termination of parental rights. Learn what steps you can take to prepare for a lifelong relationship with a child adopted out of foster care and how to prevent the disruption of an adoptive placement. Presenters: Kristi Lovelace and Bonnie Lockwood

B-2. THE IMPORTANCE OF MAINTAINING SIBLING CONNECTIONS: This workshop will help caregivers understand the need for siblings to be together. Participants will learn the long-term impact of sibling connections and what happens when those bonds are severed. Participants will learn ways to partner with the Division, relatives, and other caregivers to maintain healthy and solid relationships of siblings in their care. **Presenters: Candis Jones and Deborah Burrus**

B-3. UNDERSTANDING TRAUMA AND BRAIN DEVELOPMENT: HOW CAN I BUILD RESILIENCY IN MY CHILD?: It is safe to say that all children who enter foster care have experienced some form of trauma be it mild, moderate, or severe. Most children return to normal functioning after they have experienced a traumatic event, while others may exhibit symptoms of post-traumatic stress. Often parents are not equipped to provide the support their children need. However, by becoming trauma informed and learning the power of habits, parents will be able to provide appropriate emotional, social, and academic support to their child. Presenter: Natasha La Marr.

<u>B-4. BENEFITS OF FOSTERING A TEENAGER:</u> Through this workshop, you will obtain knowledge of all benefits that the Independent Living Program (ILP) offers the youth that are 14 and up in your home. You will obtain knowledge of all areas of ILP and how you can assist your youth to ensure that he or she receives all the benefits of ILP. All our youth have rights and you will obtain knowledge of these rights. At the end of this workshop, you will have knowledge of all areas of ILP and how important it is for the youth placed in your home to take advantage of the ILP. **Presenters: Teresa Reese and Estelline Beamon**

B-5. EDUCATIONAL RIGHTS FOR CHILDREN IN FOSTER CARE: Children in foster care consistently experience some of the lowest educational outcomes of all youth. Research demonstrates that every time a child changes schools, he or she loses up to six months of his or her education. Many foster youth may change schools 10-15 times throughout his/her education. Furthermore, many foster children suffer from the emotional ramifications of the incidents that led to their placement in foster care, and this can lead to acting out and avoidance of school. Come learn how you can be a good educational advocate for your foster or adoptive child. **Presenter: Craig Goodmark**

B-6. KEEP CALM, CONNECT, AND REDIRECT: TOOLS FOR BEHAVIOR MANAGEMENT: One of the most challenging aspects of parenting is disciplining effectively. This workshop will offer tools and techniques to address tough child and adolescent behavior. Participants will have the opportunity to problem solve together some of their toughest challenges and leave with a plan of action.

B-7. POST TRAUMATIC STRESS DISORDER (ANOTHER PERSPECTIVE): Foster children are now being diagnosed with Post Traumatic Stress Disorder (PTSD). B-9. THE FORTY DEVELOPMENTAL ASSETS FOR SUCCESSFUL YOUTH: In this engaging, hands-on workshop, participants will explore the Search Institute's 40 Developmental Assets and how they relate to positive youth development. Participants will also gain tools and resources for immediate implementation. Join us for this fun networking and learning opportunity. **Presenter: Mary Kate Chapman**

B-10. COMPLEX TRAUMA INFORMED APPROACH TO CHILDREN IN FOSTER CARE: The term complex trauma describes the dual problem of children's exposure to multiple traumatic events and the impact of this exposure on immediate and long-term outcomes. Typically, complex trauma exposure results when a child is abused or neglected, but it can also be caused by other kinds of events such as witnessing domestic violence, ethnic cleansing, or war. Many children involved in the child welfare system have experienced complex trauma. In this workshop, you will learn about the current science and how the child welfare system is shifting in response to this new information and how it can impact your foster or adoptive child. Presenters: Judge Michael Key and Michelle Barclay

C-3. EARLY DETECTION OF DEVELOPMENTAL DELAYS AND DISABILITIES: The Georgia Department of Public Health (DPH) in collaboration with Georgia Division of Family and Children Services is leading a training initiative for educating parents on the early signs of developmental delays, disabilities, and chronic health conditions in children 0-5 years. In this workshop, you will improve your knowledge and awareness of developmental delays to better identify signs of concern and how to connect to appropriate screenings and interventions. A review of the most common developmental disabilities and a developmental milestone tracker for caregivers will be included in this presentation. **Presenter: Rita Young**

<u>C-4. COORDINATED TRANSITION PLANNING FOR YOUTH WITH SEVERE DISABLITIES:</u> Transition planning for youth with severe developmental and mental health disabilities can be extremely challenging. This workshop is designed to provide participants with information on how and when to apply for Medicaid waivers and social security benefits for youth preparing to transition from foster care. Participants will also receive information on various community services and resources designed to prevent homelessness and promote a seamless transition. Presenter: Estelline O. Beamon and Brigette Miller

<u>C-5. TOOLS FOR TRAUMA RESPONSIVE PARENTING:</u> Responsive parenting after trauma emerged as a core theme, consisting of being aware of a child's needs and acting on these needs. This workshop will explore 14 strategies that parents may use to be a trauma responsive parent. This workshop will integrate tools from the Georgia Center for Resources and Support that can help parents sharpen their awareness of a child's needs and act appropriately in responding to these needs. **Presenter: Brenda Gillespie**

C-6. MEETING THE WELL- BEING NEEDS OF CHILDREN AND PSYCHOTROPIC MEDICATION: Wellness Programming Assessment and Consultation (WPAC) in partnership with Amerigroup will present information regarding well-being needs of children. This presentation will include an overview of the role of WPAC and Amerigroup. WPAC and Amerigroup will address topics such as Early Periodic Screening Diagnostic and Treatment (EPSDT), dental exams, Trauma/Developmental Assessment, psychotropic medications, scheduling medical appointments, and preauthorization for medication. Presenters: Shemika Harris and Shauna S. Malone

C-7.
