Discharge Data Collection: DFCS Notifications

Effective 7/1, when a provider reports a discharge (or FH transfer) from the GA+SCORE Daily Roster, they must also report on the notification that was sent to DFCS.

Please be prepared to report these three items:

1. Discharge Notice Date
2. Discharge Notice Timeframe (RBWO Minimum Standard 5.5-5.6)
3. Discharge Notice Comments
 - Comments are OPTIONAL for notifications sent on time per the standards
 - Comments are REQUIRED for notifications sent outside those timeframes (Emergency or Other)

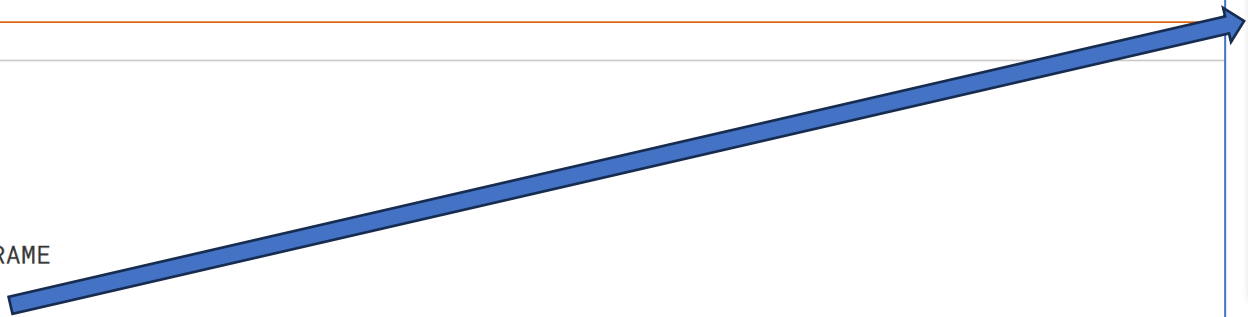

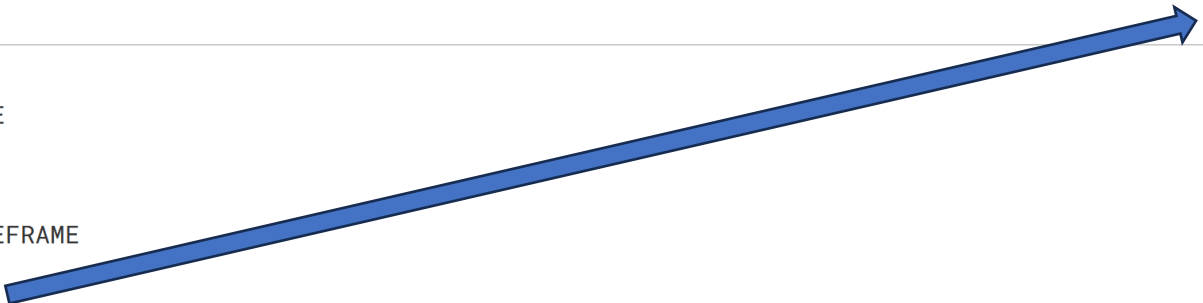

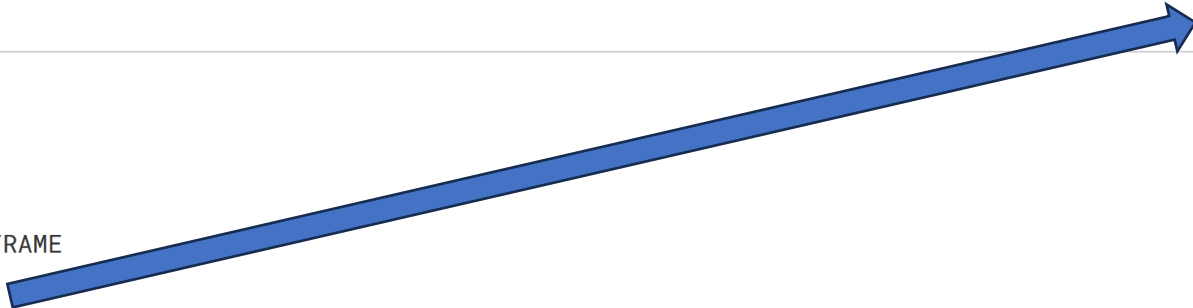

Discharge Data Collection: CPA Transfers

Effective 7/1, the reporting process is slightly different when a youth moves between two foster homes at the same program site in GA+SCORE.

On the discharge screen, the dropdown **Discharge Reason** will no longer contain “Child moved to another foster home within the same program”. Instead, select the best available option to describe why the youth is moving. Then select YES or NO to the new dropdown **Transfer to another home at this program?**

RBWO Referrals

As a reminder, per RBWO Minimum Standards 4.14 & 4.15, placement referrals must be documented in GA+SCORE. **That includes referrals that your agency does not admit.**

- Providers are NOT required to report an informal referral, such as a phone call or an email without attachments, unless it leads to a placement.
- Providers ARE required to report any time they receive a completed Universal Application for a potential placement, even if they do not accept the placement. The referral and your agency's decision must be reported on the orange Rosters >> Referrals page within 15 business days of receipt.

Argo Placements Portal in SHINES

To assist DFCS case managers and CCTU staff in locating appropriate placements, please be sure that your program's data is correct in GA+SCORE – information is sent to SHINES at the end of each month.

- Programs >> Program Information page (e.g., program description)
- Programs >> Contact Information page
- Services tab (including youth ages, genders, and characteristics)

Other information for Argo comes from your RBWO contract and from record-keeping in SHINES.
