
Identity History Summary (IDHS)

- A new application to assist the Department of Human Services, Office of Inspector General, Background Investigations Unit in retaining background checks requested by the Office of Human Resources and DHS providers.
- Providers will retrieve their applicant's determination letters via the IDHS website. Letters are accessible 24/7.
- Provider Go-Live Date: July 1, 2018



Accessing IDHS

 Access to Identity History Summary (IDHS) can be obtained through the following link: <u>https://idhs.dhs.ga.gov/</u> The link will not work properly if using Internet Explorer. It is highly recommended that providers use the Google Chrome or Mozilla Firefox internet browsers for access. 

Accessing IDHS

The Home screen will appear once the provider accesses the link.

 Unauthorized access to the site is strictly prohibited. This website should only be used to access information belonging to your agency. Use of this site is restricted to authorized users and subject to monitoring.


Once the provider has read and accepted the disclaimer, click Proceed to enter the site.





Retrieval of Determination Letter

- Once providers are in the site, letters can be searched by either the GAPS Registration ID number or the Requesting Agency GAC/GAP number . Enter either number into the appropriate field.
 - A Registration ID is 15 digits consisting of letters and numbers that is assigned when an applicant is registered through Gemalto for fingerprinting.
 - Example: GA00a0a0a00a000
 - The Agency GAC/GAP
 number is the Requesting
 Agency number
 - Example: GACXXXXX or GAPXXXX





Retrieval of Determination Letter

Click on the Document to open the determination letter. Providers may print the letter for the applicant's file.

Letters can only be used for the agency specified. Sharing of letters between agencies is prohibited. For every new position or agency of employment, a fingerprint-based background check must be performed.


Registration ID

- The Office of Inspector General will not provide the provider or applicant with the applicant's Appointment number if misplaced. It will be the provider's responsibility to maintain the Registration ID or GAC/GAP number once the applicant is registered through Fieldprint.

Clearance Letter: Applicant is eligible to provide services







Determination Letters

Disqualification Letter: Applicant is disqualified to provide services to DHS or an agency with a contract with DHS based on DHS Policy #504. If the applicant is currently employed with the agency, termination from employment requires immediate action.

If the applicant has direct child care, they would select: DHS-Health Agencies/Contractors Providing Direct Child Care. If the applicant has direct elder care, they would select: DHS Health Care Agencies Contractors Providing Direct Elder Ca If the applicant does not have direct care, custodial, or treatment of a client, they would select: DHS - Employment Contract			
What happens if I select the incorrect Reason Code?			
Criminal Records received with an incorrect Reason Code cannot be processed. Your agency will be notified that the applicant	nt must be re-registered and pay again.		
When I select the DHS as the agency making my determination, what ORI Number do I use to ensure DHS receives the	he results for review?		
The only approved DHS ORI # for Cogent is GA920280Z. The ORI is automatically populated into the Reviewing Agency ID field and should not be altered.			
What happens if I select the incorrect agency to make the determination?			
The Criminal Record would not be processed because DHS did not receive it. Also, you would then have to re-register the ap	plicant, have them fingerprinted and pay again.		
Can I get copies of the Result Letter if I need it?			
You can retrieve as many copies of the letters as you need through the IDHS system. Letters prior to July 1st, 2018 cannot b from provider to provider.	e retrieved, and the applicant must be reprinted. Also, the letters are not transferable		
Can I cancel or change an applicant registration in Cogent?

Policy

- Applicant's background checks will be processed within 72 business hours from when the Department of Human Services receives the results from the state approved vendor.
- A clearance determination letter will be accessible by the provider immediately upon the Criminal Justice Specialist entering it into IDHS.
- Applicant's needing further evaluation will have a final determination uploaded no later than 15 business days from their initial input.
