RE: FY21 RBWO Contracts – Rate Schedules Annexes

It has come to our attention that some RBWO providers with CCI programs may have received a FY21 contract with a rate schedule annex that does not reflect the **current** standard rates as set forth in the FY21 legislative budget signed by Governor Kemp.

These contracts were sent out mistakenly prior to Governor Kemp signing the State Budget. We are asking all RBWO providers with **CCI programs only (which include ILP programs)** please review your contracts specifically the Rate Schedule Annex and verify that the rates on the annex are the **current** standard rates as outlined in the table below. If the rates do not reflect the rates below please send an email to [rbwofiscal.services@dhs.ga.gov](mailto:rbwofiscal.services@dhs.ga.gov) and we will provide you with next steps on receiving the correct Rate Schedule annex.

As previously communicated via GA E-Blast on July 21st Governor Kemp signed the state budget on Tuesday June 30<sup>th</sup>, 2020. The State budget included a slight rate reduction of (.58%) to all Child Caring Institution programs. A listing of the rates is provided below.
