OPM VS RCCL RULES

OPM

- 1. Household members **18 years** of age must be screened for **tuberculosis**.
- 1. Gas heaters in the home **must be vented** to avoid fire & health hazards. **However, unvented**, fuel-fired heaters equipped with oxygen depletion safety shutoff systems **may be operated in the homes**.
- 2. N/A

RCCL

- Screening for tuberculosis for prospective foster parent(s) & children 16 and older living in the prospective foster home. (MOST RESTRICTIVE)
- 2. Gas heaters are **vented** to avoid fire & health hazards, **with any unvented**, fuel-fired heaters equipped with oxygen depletion safety shut-off systems. (**MOST RESTRICTIVE**)
- 3. The foster home study report shall include: Willingness to cooperate with the placement agency.

OPM VS RCCL SPACE & SLEEPING ARRANGMENTS RCCL

OPM

1. Caregivers must provide a safe **sleeping space**... as appropriate for the child's needs and age.

- 1. Only bedrooms are used as sleeping space for children. (MOST RESTRICTIVE)
- 2. A maximum of two (2) children sleep in a double or larger bed, and only if they are of the same sex and under age 5.
- 3. No child over one (1) year sleeps in a room with an adult.
- 4. Children over three (3) years old of different sexes do not share a bedroom.

*Six children in the home includes 18-year-olds (biological and adoptive children). You must request a waiver for more than 6 children 18 and under.

Requesting Waivers


When requesting a waiver through **OPM**, a waiver **must** also be requested through **RCCL**.
