



### The Evolution of Provider G Focus



Data regarding substantiated maltreatment in care led us to drill into inadequate medical care which we believe is a low-hanging fruit and can be resolved fairly quickly. As a result of data analysis, we discovered a relationship between maltreatment in care and time in care, particularly, the first 30 days. As we drilled into substantiated incidents within the first 30 days, we found that the majority of those children had been in more than one placement.



- The majority of the children (82%) are residing in the CCIs or CPAs
- More than half (55%) are female.

#### Location of the Remaining 22 Children who will be 18 by March 31, 2011



## Youth Aging out of Care by December 31, 2011 (N = 542)

- 293 or 53% are girls / 249 or 47% are boys
- 160 or 29.5% have had more than one foster care episode
- Average of 4 placements (ranged from 1 to 27)
- Parental rights have been terminated for 108 or 20% of them

## Permanency Plan for Children turning 18 (N=542)

The majority of youth who will be turning 18 within the next 12 months have a permanency plan of APPLA (emancipation and/or long term foster care) or reunification.

## Policy 11.12: Extended Youth Supportive Services (Remaining In Care)

## REQUIREMENT

- The Division of Family and Children Services (DFCS) will advise all youth ages 16 and over in agency custody, verbally and in writing, of their ability to request extended youth supportive services (EYSS) after their 18th birthday.
- DFCS will allow youth to request to receive EYSS upon turning age 18 or within 6 months of emancipating from foster care.
